PRIVACY POLICY

This is the privacy policy of The Arthur Troop Pipes and Drums, based in Alkmaar and registered in the trade register of the Chamber of Commerce under number 371414899 (' the ATPD "). This privacy policy describes what personal information the website https://www.arthurtrooppd.nl ATPD processes when you visit, and the purposes for which such personal information is used.

1. USE OF PERSONAL DATA

2. USE OF COOKIES AND VISITORS REGISTRATION

- 2.2 Where, as a result of the registration of IP addresses, information is posted or read out and this is not strictly necessary for the performance of the communication with you or for a specific service requested by you, you will be informed in advance and be asked for

permission. See the cookie manager. It is possible that some parts of the website without cookies etc. will not function properly.

5. THIRD PARTIES

5.1 The ATPD will not provide your information to third parties unless you have given your expressed permission or is required to do so on the basis of the ATPD by law or court order.

6. PERSONAL DATA AUTHORITY NOTIFICATION

- 6.1 The Arthur Troop Pipes and Drums has not reported the personal data to the Authority of Personal data Authority.
